▶ NEW for 2014 Administration

Test Administrator Training Course

- Due to changes in the administration of the listening component, all test administrators must certify or recertify on the group module, which addresses the listening component, in addition to the speaking module.
- Due to updates to the online training course, this certification/recertification must take place from October 7, 2013—January 26, 2014.

▶ Test Facilitator Responsibilities

Test Facilitator is responsible to:

- Oversee all aspects of testing
 - Ordering, receiving, returning test booklets
 - Schedule testing times/locations
 - Maintain test security
 - Train test administrators
 - Collaborate with PIMS Coordinator to ensure accurate upload to PIMS ACCESS for ELLs data collection
 - Ensure that all test administrators receive the Special Instructions for Pennsylvania sheet (goldenrod sheet)
- Maintain LEA's W-APT login
- Create personal accounts for test administrators
- Update LEA's personal accounts—add new and remove obsolete
- Assign training modules to eligible test administrators.
- Collect test administrators' test security and non-disclosure agreements
- Verify course certificates documenting test administrators' completion of on-line training course modules



▶ Test Administrator Responsibilities

Test Administrator is responsible to:

- Update personal information (school, district) in the online training course by clicking on “My Account”
- Complete online training course modules as assigned by the Test Facilitator, including the kindergarten module
- Read and sign the test security and non-disclosure agreement
- Download and print *Kindergarten Test Administration Manual*
- Read and follow Special Instructions for Pennsylvania (goldenrod sheet)
- Print and provide to the Test Facilitator certificates of completion for assigned online training modules
 - Review feedback
 - Retake as necessary to meet each criterion

▶ ACCESS to Online Training Course

Test Facilitator:

- For LEAs who are ordering assessments for the first time, the designated ACCESS for ELLs test facilitator must contact PDE and provide your AUN number. PDE will contact WIDA and WIDA will provide you with a W-APT login.
- If you forget your password, contact WIDA (help@wida.us) and they will send you a link to reset your password.

▶ ACCESS to Online Training Course

Test Administrator:

- For first time test administrators, your LEAs' test facilitator must create a personal account for you to enter the ACCESS for ELLs online training course.
- Contact a department supervisor or building administrator at your LEA to identify your test facilitator.
- If you forget your password, contact WIDA (help@wida.us) and they will send you a link to reset your password.

▶ Test Administrator Eligibility Requirements

A test administrator must:

- Be a certified teacher
- Have knowledge of the WIDA levels of English language proficiency and PA English Language Proficiency Standards (PA ELPS) and have experience teaching English language learners
- Complete the WIDA on-line training course modules with passing quiz scores of 80%
- The speaking quiz must be retaken every year in PA
- A reading specialist or any certified teacher who meets these criteria is eligible to administer the assessment

Test Administrator Certification Requirements

A test administrator must:

- Meet eligibility requirements (listed on previous slide)
- Complete the training modules assigned by the test facilitator and obtain a score of 80% or higher
 - Overview
 - Group
 - Speaking
 - Kindergarten
 - **Alternate**
- Retake the speaking module every year
- Provide proof of training to test facilitator
- NEW for 2014 administration: all test administrators must certify or recertify on the group module, which addresses the significant changes to the administration and delivery of the listening component.
- Certification/recertification must take place from ~~October 7, 2013~~ January 26, 2014, due to updates to WIDA's online training course.



Welcome!

This course will prepare you to administer the annual ACCESS for ELLs assessment of English language proficiency. It consists of 4 modules:

- Overview Module (Note: this module does not include a quiz)
- Group Test Administration Module (covers Listening, Reading, Writing tests)

▶ Online Training Course (Modules)

Overview Module:

- Provides background on the ACCESS for ELLs test
- Provides links to the Test Administration Manuals (Kindergarten and Grades 1-12)
- Provides information about accommodations for students with disabilities

▶ Online Training Course

Group Components Test Training:

- Provides essential background on the structure of Listening, Reading, and Writing items
- Provides sample test items
- Provides a quiz to test knowledge and skill with group administered components of the test & to establish certification/approval to administer the test

Online Training Course

Speaking Test Training:

- Provides essential background in the Speaking test and Speaking items
- Provides samples of responses at all grade levels and proficiency levels.
 - Samples provide models for standardization of administration procedures.
 - Samples allow for calibration on the scoring rubric
 - Calibration better assures inter-rater reliability
- Provides a quiz to test knowledge and skill with Speaking test and to establish certification/approval to administer test

▶ Online Training Course

Kindergarten Test Training:

- Provides essential background on the unique aspects of administration of the Kindergarten test
- ALL components of the test are individually administered and scored by the test administrator
- Provides sound samples of kindergarten responses
 - Samples provide models for standardization of administration procedures.
 - Samples allow for calibration on the scoring rubric
 - Calibration better assures inter-rater reliability
- Provides a quiz to test knowledge and skill with Kindergarten test and to establish certification/approval to administer test



Online Training Course

Quiz Details:

- Each quiz includes 10-20 questions
- Quiz is “passed” at 80% correct
- Quiz results, feedback, and correct answers are available after completion of the quiz
- Quiz may be retaken as necessary
- Only highest graded attempt is recorded in the grades section
- A certificate will be available to print once a quiz is passed and will be accessible at any time

▶ PA-Specific Guidance for Test Administration

ACCESS for ELLs Kindergarten must be administered:

- By appropriately certified test administrator
- During the test window (January 27-March 7, 2014)
- According to PA-specific instructions on the Special Instruction Sheet (goldenrod sheet that accompanies testing materials)
- Using WIDA's guidance for accommodations for students with disabilities

▶ Accommodations for ELLs with Disabilities

- Apply only to ELLs with disabilities
- Must be stated in the student's IEP or 504 Plan.
- Are provided in the *Kindergarten Test Administration Manual*

Reminders:

- Students should be encouraged to complete as much of the assessment as possible. However, no student, including those students with disabilities, should be required to continue the assessment if evidence of the frustration level and inability to continue is evident.
- See page 24 of the *District and School Test Administration Manual* for instructions on how to code students with exemptions for **Special Education/504** reasons.
